My Own Analytical Review: The George Floyd Situation And The Police; A Review

The specifics of the transcripts of the officers and Floyd speaking, as written up in Spectator, is tremendously valuable.

Given that Floyd was high:

- 11. The third cop apparently followed a rulebook guideline available to him, from cop standard rulebook.
- 12. I'm not sure why he applied this rule at that time, even if it was available.

- 13. Resisting or communicating is not necessarily violent or a threat.
- 14. If I were the third cop, and had Floyd under a knee pin, if Floyd was actually a threat or violent, then I would have released the knee every minute or so for 15 seconds: to let Floyd breath, and to let Floyd demonstrate cooperation, such that no further knee pin was necessary at all.
- 15. That way Floyd would have had a better chance of surviving. And it would have been realistic policing. The results then would have spoken for themselves. Floyd may or may not have survived. But the chances, given the opportunity to breath well, and to have access to water or iced tea, and air, and space, would have improved the odds.
- 16. If there was no if-then rule in the rulebook, then is the cop A, B, C to be faulted, or how much, or in any penalized or criticized for false judgment; and should the rulebook be updated to reflect this obscure field called 1) projection of a thing, electron, sphere, person, or field; 2) logic, realism, and awareness; 3) an actual situation. Cop A, B, C should be safe. Floyd should be non-violent, and may have been, if he wanted to cooperate; and Floyd should have been given options above to better have a chance to survive, perhaps, and may have cooperated to the best of his at-the-time-in-fact ability and sense-awareness to clearly communicate.

A corollary argument, with respect to society.
